## **ORDER FOR BANNING OF BUSINESS**

An NIT bearing no. SO(EnM)/BnK/Explosive Van/21-22/35 dated 19.11.2021, Tender ID: 2021\_CCL\_223420\_1 for the work titled "Hiring of one (01) no. explosive van of capacity 10 Te on 24 hours basis for a period of (03) three years to be engaged at Karo OCP, B&K Area" was floated on CIL e-Procurement Portal and simultaneously on CCL Tender portal vide Tender Id- 75504.

After opening of the bid on scheduled date & time, PRADEEP KUMAR SINGH, At: Kurpania, PO-Sunday Bazar, PS- Gandhi Nagar, District- Bokaro (Jharkhand) 829127 was found to be L-1 bidder. Moreover, Technical Evaluation of documents uploaded by L-1 bidder i.e. PRADEEP KUMAR SINGH was done as per NIT and some deficiency was found by Tender Committee in the uploaded documents. Accordingly, PRADEEP KUMAR SINGH was asked online to upload required shortfall documents within scheduled time from 16.12.2021 at 15:00Hrs to 23.12.2021 at 15: 00Hrs (07 days) on e-portal of Coal India Limited as per clause no. 13.B of the e-NIT. PRADEEP KUMAR SINGH has not uploaded the required relevant shortfall document with the said scheduled time period.

As per clause 13.E of the e-NIT, which states that:

"In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected and the bidder will be banned for two years from being eligible to submit Bids in CIL and its subsidiaries. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal."

Under the above facts and circumstances, as per clauses 13.B & E under Tender Evaluation of the NIT, the business in the name and style M/s PRADEEP KUMAR SINGH, Proprietor: - Pradeep Kumar Singh, Address: - Kurpania, Kurpania, Sunday Bazar, Gandhi Nagar, Bokaro, Jharkhand, 829127, login id:- pradeep.bermo@gmail.com, PAN:- AZRPS3839D & GSTIN:- 20AZRPS3839D2Z7 is hereby banned for 02 (Two) years from being eligible to submit bid in CIL and its subsidiaries with immediate effect.
