## ORDER FOR BANNING OF BUSINESS

An NIT bearing No. "GM(R)/SO(EnM)/Rjp/21-22/Et/11 Dated:25.05.2021, Tender ID-2021\_CCL\_207013\_1 for the work "Complete repairing/rewinding of 01 no. 200KW, 415V, 1488 RPM NGEF Make induction motor SI No. 12616603 of Rajrappa Washery Project" was floated on CIL e-procurement portal.

After opening of price bid on scheduled date & time, Pooja Electricals were found L-1 bidder. After all the tender formalities, work was awarded to bidder successfully vide LOA No: GM®/SO(EnM)/Award of Work/21-22/324 dated 07.09,2021.

As bidder submitted electrical license of Chhattisgarh in tender, so at the time of issuing LOA, he was asked to submit electrical contractor's license from Jharkhand Licensing Board for working in the state of Jharkhand as per clause 6.c of NIT but bidder neither submitted license of Jharkhand Government nor any reply was received from him after giving intimation in this regard.

In view of above facts, as per Bid securing declaration of NIT, bidder accepted that "if I/We withdraw or modify my/our Bid during the period of validity, or if I/we are awarded the contract and fail to sign the contract agreement, or to submit performance security before the deadline as per NIT/ Tender document / Letter of award or any other default made by me/us till execution of agreement as defined in the NIT/Tender Document, I/we will be banned for 02 (two) years from being eligible to submit Bids in CIL and its subsidiaries." This banning shall be done under the provision of NIT and online blocking of all the bidders shall be done in CIL e-procurement portal.

Under the facts and circumstances mentioned above, as per clause 3, bid security declaration of NIT, business in the name M/S Pooja Electricals, Ward No.17 Main Road, Chanwaridand Ata Chowk Manendragarh, Chhattisgarh, PAN- AVJPS2408N, mail id- <a href="mailto:birendrakumarsinghmdgr@gmail.com">birendrakumarsinghmdgr@gmail.com</a> is hereby banned for (02) two years from being eligible to submit bids in CIL and its subsidiaries with immediate effect.
