ORDER FOR BANNING OF BUSINESS

An NIT bearing No. "GM(R)/SO(EnM)/Rjp/21-22/Et/04 Dated:15.04.2021, Tender ID-2021_CCL_204356_1 for the work "Supply, installation, testing and Commissioning of 03 nos. of 3.3KV, 10A NGRs complete with NGR monitoring system with protective relays for 03 nos of 3MVA,6.6KV/3.3KV Transformers of (a) make-Andrew Yule, SI No.-11366 (b) make-Bharat Bijli, SI No.-2469/1 & 2469/2 installed at 2x12.5MVA,33KV/6.6KV Main substation of Rajrappa Project" was floated on CIL e-procurement portal.

After opening of price bid on scheduled date & time, M/S Umashree Engineering was found L-1 bidder. After all the tender formalities, work was awarded to bidder successfully vide LOA No: M®/SO(EnM)/Award of Work/21-22/249 dated 29.07.2021.

After awarding the contract, bidder had to sign the work order for execution of work, but bidder neither came to sign work order nor any reply was received from him after giving intimation in this regard.

In view of above facts, as per Bid securing declaration of NIT, bidder accepted that "if I/We withdraw or modify my/our Bid during the period of validity, or if I/we are awarded the contract and fail to sign the contract agreement, or to submit performance security before the deadline as per NIT/ Tender document / Letter of award or any other default made by me/us till execution of agreement as defined in the NIT/Tender Document, I/we will be banned for 02 (two) years from being eligible to submit Bids in CIL and its subsidiaries." This banning shall be done under the provision of NIT and online blocking of all the bidders shall be done in CIL e-procurement portal.

Under the facts and circumstances mentioned above, as per clause 13.3.b under bid security declaration of NIT, business in the name M/S Umashree Engineering, Main Road Bhatgaon, Ward No.10, PO-Bhatgaon, Distt-Surajpur, PAN- BEQPS9937H, mail-umashreeengineering@gmail.com is hereby banned for (02) two years from being eligible to submit bids in CIL and its subsidiaries with immediate effect.
