This is for information to all the successful bidders of Single Window Mode Agnostic e-Auctions conducted by CCL in respect of STEAM size coal that inadvertently the Price of said type of coal was mentioned incorrectly for arriving at Notified/Reserve Price of Coal for e-Auctions held on 28.04.2023 / 02.05.2023 (**Phase-I**) and 20.06.2023 (**Phase-II**).

In this regard, an additional 1.26% of STEAM sizing charges i.e., 1.26% of Rs 270 (along with applicable premium) is required to be levied from such bidders (as part of Modulated base Price), in terms of CIL guidelines dated 22.03.2023 regarding Modulation of Price with WPI Indexation.
