

CCL/HQ/C-4/E-AUCTION/173-H dated 13/02/2024 along with the terms & conditions of Single Window Mode Agnostic E-Auction on the website of CMPDIL & CIL/CCL, for the E-Auctions of raw coal/Washery products held on **19.02.2024 and 20.02.2024** by **M/s CMPDI Limited**, all the successful bidders are hereby advised to deposit full Coal value (**after adjusting the EMD of Successful Bid Quantity**) along - with statutory charges, levies, duties and taxes as applicable upto **04th March 2024** **through the banking interfaces only as notified by CCL from time to time.**

Please note that, as per the terms & conditions of the E-Auction, in case the coal value is not deposited within the stipulated time, as above, by a successful bidder, the EMD shall be forfeited, as per the forfeiture clause of EMD of Single Window Mode Agnostic E-Auction Scheme.

All the new successful bidders at CCL are required to furnish the details of maximum two of their bank account in the prescribed format available at CCL website (www.centralcoalfields.in) as well as at CSC, CCL Ranchi. All the successful bidders have to remit the coal value through the declared bank account only, failing which their transaction will not be honoured. Pre-registration of bank details is a must before remitting coal value to CCL. Further, the refunds if any will be done on any one of the bank account provided by the bidders.

Consumers are requested to make payment of coal value using Collection Portal of the banks as notified by CCL from time to time.
