NOTE:

- Consumers are requested to make payment of coal value using collection portal of the banks as notified by CCL from time to time.
 - In addition to bid price other add on prices, if any, will be recovered, Statutory charges and Govt. levies will be charged as applicable on the date of delivery.
 - Before participating in e-auction bidders must satisfy themselves with the quality of the coal being offered from a source
 - In addition to above, GST, Sales Taxes, Royalty, SED, Excise Duty, GST Compensation cess, Commitment Charge, beneficiation charge, Surface Transportation Charges, Sizing Charge & any other charges as applicable will have to be paid by buyers at CCL.
 - Price is available on company website www.centralcoalfields.in for non-coking & coking coal.
 - The refunds shall be made only to the Account no. and the bank through which the coal value will be deposited and as per e-mandate provided by the customer to CCL.
 - EMD for all types of coal will be ₹ 500/- per tonnes.
 - All selective loading irrespective of means of loading and modes of dispatch to be considered as loading of steam sized coal of +25 mm. Therefore, in case of selective loading, a steam sizing charge, which is presently ₹ 274/- per tonne, be charged on the ROM price on account of sizing.
 - In addition to above, beneficiation charge be levied for all selective loading. The beneficiation charge shall be the price difference as per the grades identified in the grade notification of the coal company for steam and ROM respectively.
 - The selective loading charge from the ROM be the summation of the sizing charge i.e. ₹ 274/- per tonne and the difference of price arising out of the grades of steam and ROM.
 - Participation of auction consumers in the bidding process through this notice will mean that the bidder accepts and agrees for all the terms and conditions of the scheme as well as this notice in totality.
 - Auction shall be conducted on the floor price i.e. reserve price for each cluster
 - Percentage premium will remain constant throughout lifting period of the particular e-auction.
 - Bid price shall be subject to revision with the changes in notified price/modulated price of coal if any and as per relevant clause in scheme document
 - Change in bid price shall only be upward in nature i.e. only upward notified price/modulated price revision shall be considered. In case of downward revision on notified price/modulated, the bid price at the date of bidding shall prevail at the time of supply.
 - Refund process of sale orders under road mode shall be completed following due formalities of scheme document, within 15 days of lifting validity date
 - The consumers taking coal under Rail mode should ensure compliances related with Mining permit, JIMMS portal etc. Related documents like Form-B, Form-H should be made available at siding/mine/Area well in advance
