Sub: Supply of G-11 grade coal from Magadh OCP against FSA of G-12 grade under Linkage Auction Policy

This is for kind information to all Non-power consumers having FSA of G-12 grade coal from Magadh OCP that as per Linkage Auction Policy that they are allowed to book/ lift G-11 ROM grade coal from Magadh OCP against the FSA executed for G-12 grade coal against their FSAs w.e.f. quota of April'23. This facility is applicable for sale orders where no lifting has taken place and for cases where sale orders are yet to be issued.

For Sale orders that have already been issued and sent to area and no lifting has taken place, fresh sale orders will be issued after closing of Sale Orders by Area and deposition of differential amount by affected consumers.

This facility is also applicable for sale orders of previous month(s)'s quota where no lifting has taken place. Last date for deposition of differential coal value for such sale orders of previous month(s)'s quota shall be 21.04.2023.

All concerned consumers, who are interested in availing the facility of supply of coal of grade other than the grade mentioned in their FSA, are required to submit their consent and Price differential (as per applicable price & premium) for issuance of Sale Orders as per above. In case if any of such consumer is not interested in lifting coal of grade other than the grade mentioned in their FSA, may contact this office for further needful as per relevant provisions of FSA/guidelines.
