Sub: Notification for Charging market fee @1% on basic value of the coal under JMADA as separate pricing component by name of "Bazaar Fees" by CCL.

Referring to sec 90A(I) & (II) of JMADA Act, Jharkhand Mineral Area Development Authority, Dhanbad (JMADA) vide letter No बाoफीoशाo-09/2023-24/06 dated 16.05.2023 directed for levying of Bazaar Fees on sale of coal and coke @1% of the basic value of coal/coke from the projects/areas falling within the jurisdiction of JMADA, Dhanbad i.e. all projects/areas of Bokaro and Dhanbad district.

The payment so made by CCL shall be recovered from the consumer with effect from 01/04/2023 @ 1% of the basic value of the coal as an additional charge with the name "Bazaar Fees". This charge shall be included as an additional component in the coal sale bill and shall be implemented with immediate effect.

The recovery of "Bazaar Fees" from the customer against the coal sale bill for the period prior to FY 2023-24 shall be done after finalisation of the modus-operandi in this regard.
