Since there is no arrear at Rajrappa Washery siding and supply is expected to be provided by South Eastern Railways soon after placing of indents, CCL shall not be able to take allotments for cases where mining permit approval has not been received and EMD against such cases shall be forfeited accordingly.

CCL has been notifying the matter since beginning and consumers have been informed several times regarding mining permit. It is again notified that above named consumers should immediately provide details to Area Sales Manager, Rajrappa Area for filing of mining permit (if not provided earlier) and to co-ordinate/ follow up with District Mining Office for grant of mining permit so that allotments can be taken within sanction validity period of rail program. - 1) All consumers who have bid for coal under Rail Mode in auction held on 02/05/2023 are hereby notified to provide details of deposition of coal value (as per notice referred above) and details of filing of rail program in FOIS latest by 17/05/2023 . The details may preferably be provided as per proforma attached herewith.
- 2) Consumers are also notified to provide details pertaining to mining permit application to Area Sales Managers of respective sidings for which rakes have been bid latest by 17/05/2023 so that required formalities for obtaining mining permit from District Mining Officers (DMOs) can be applied from siding/ area in JIMMS Portal of Dept. of Mines and Minerals, Govt. of Jharkhand (hereinafter referred as JIMMS) .
- 3) CCL shall only apply for permits in JIMMS subsequent to deposition of required details by consumer. It shall be consumer's responsibility to maintain follow-up with DMOs, if required, for grant of permits. Offer / Indent shall be placed only after receiving confirmation from Area Sales Managers regarding receipt of required permits from DMOs. Consumer shall be solely responsible for any loss of seniority/ non-placement of offers and indents by CCL/ loss of loading and subsequent forfeiture of EMD due to delay/ non approval of permit applications by DMOs.
- 4) Consumers who have submitted Bank Guarantee in lieu of advance coal value are requested to arrange for deposition of coal value subsequent to notification (to be sent by e -mail from CCL as provided by consumers) so that offer/indent can be raised.
