NOTICE

<u>Sub: Supply of G-5 grade coal from North Urimari OCP against FSA of G-7 grade under Linkage Auction Policy</u>

This is for kind information to all Non-Regulated sector consumers having FSAs of G-7 grade coal under NRS Linkage Auction Scheme from 'North Urimari OCP'/Bhurkunda OCP' as Primary source(s) that as per Linkage Auction Policy, due to change in grade at North Urimari OCP and non availability of coal at Bhurkunda OCP as informed by area, they are allowed to book/ lift G-5 ROM grade coal from North Urimari OCP against their FSAs executed for G-7 grade coal w.e.f. quota of Nov'23 onwards till coal of G-7 grade gets available at North Urimari OCP/Bhurkunda OCP. This facility is applicable only for sale orders where no lifting has taken place and for cases where sale orders are yet to be issued.

For Sale orders that have already been issued and sent to area and no lifting has taken place, fresh sale orders will be issued after closing of Sale Orders by Area and coal value deposition by affected consumers.

This facility is also applicable for sale orders of **previous month(s)**'s **quota** where no lifting has taken place and for cases where sale orders are yet to be issued. For Sale orders that have already been issued and sent to area and no lifting has taken place, fresh sale orders will be issued after closing of Sale Orders by Area. Last date for coal value deposition for sale orders of **previous month(s)**'s **quota along with request for release of coal with revised grade** shall be **16.11.2023**.

All concerned consumers, who are interested in availing the facility of supply of coal of grade other than the grade mentioned in their FSA, are required to submit their consent for issuance of Sale Orders as per above. In case if any of such consumer is not interested in lifting coal of grade other than the grade mentioned in their FSA, may contact this office for further needful as per relevant provisions of FSA/guidelines.
