

- 1) All consumers who have bid for coal under Rail Mode in auction held on 12/01/2024 are hereby notified to provide details of deposition of coal value (as per notice referred above) and details of filing of rail program in FOIS by 25/01/2024. The details may preferably be provided as per proforma attached herewith.
- 2) Consumers are also notified to provide details pertaining to mining permit application to Area Sales Managers of respective sidings for which rakes have been bid so that required formalities for obtaining mining permit from District Mining Officers (DMOs) can be applied from siding/ area in JIMMS Portal of Dept. of Mines and Minerals, Govt. of Jharkhand (hereinafter referred as JIMMS) .
- 3) CCL shall only apply for permits in JIMMS subsequent to deposition of required details by consumer. It shall be consumer's responsibility to maintain follow-up with DMOs, if required, for grant of permits. Consumer shall be solely responsible for any loss of seniority/ non-placement of offers and indents by CCL/ loss of loading and subsequent forfeiture of EMD due to delay/ non approval of permit applications etc. by DMOs.
