This is for kind information to all Non-Regulated sector consumers having FSA of W-III Steam coal from 'SDOCM OCP' as Primary source with 'AADOCM OCP' as Secondary source that as per Linkage Auction Policy of CIL, concerned consumers are hereby provided a dispensation to book/lift W-III Steam coal from AADOCM OCP (Secondary Source) and AKK OCP (Tertiary Source) to the tune of 20% linked quantity and 30% linked quantity respectively against such FSAs of W-III steam grade coal from SDOCM OCP (Primary Source). Balance 50% linked quantity has to be booked from Primary source i.e SDOCM OCP.
