Subject: Discontinuation of Road/RCR dispatch for Power Companies w.e.f. 1st April 2024

Dear Sir,

This is in reference to the earlier letters issued vide reference no: CIL/M&S/Wagon Loading/109 dated 16.02.2024 & CIL/M&S/Wagon Loading/145 dated 08.03.2024 regarding the above-mentioned subject.

As stated in the letter with effect from 01.04.2024, the delivery/supply of coal from ECL, CCL, NCL and WCL would be discontinued for supplies made under FSAs to Power Sector for FY 2024-25 through road mode including RCR unless the Power sector consumers specifically request for coal supplies through Road/RCR mode. Further, in cases where in the FSAs/LoAs and/or in bid document, the mode of transport is specifically mentioned as "Road/RCR" Mode only, supplies may be made as per the FSA/LoA and/or bid document provisions. However, for delivery/supply of coal through Road/RCR mode, the consumer is required to submit their written request to the coal companies.

In this regard, based on the request received from the consumers, a standard format which was shared earlier dated 08.03.2024 with coal companies for 'opting to lift coal through road/RCR mode in FY 2024-25' has been simplified for ease of understanding and copy of the same is enclosed herewith for necessary action at your end.

Coal companies are requested to circulate the same so that the willing Power Companies can submit their request in the enclosed simplified format for opting Road/RCR mode of dispatch.
