NOTICE

Subject: Change in Capacity of End Use Plant under Auction of NRS coal linkages
Tranche-VI for Cement, CPP, Others(non-coking) & Others(coking) subsectors

In order to provide a scope to the interested Bidders of (1) Sponge Iron, (2) Cement, (3) CPP, (4) Steel(coking), (5) Others(coking) & (6) Others(non-coking) subsectors under Linkage Auction (non-regulated sector) tranche VI to revise the capacity or any other relevant details of their End Use Plants (EUP) registered on the MSTC Linkage Auction portal, a 7-days window from 22.11.2022 to 28.11.2022 shall be available.

The process to be followed in this regard shall be as under:

- a. The bidders of the above mentioned subsectors seeking change/modification in their EUP capacity/relevant details shall intimate about such change to MSTC Ltd. from their registered e-mail IDs within the window from 22.11.2022 to 28.11.2022, along with necessary documents & certification of statutory authority evidencing/approving such change (wherein such change is mentioned) vis a vis earlier submitted/relevant documents in this regard in pdf format not exceeding 4 MB (in size). In case of request for enhancement of Capacity of the plant, submission of the revised CTO/certificate of Pollution Control Authority allowing the enhanced capacity vis a vis earlier CTO/Pollution control certificate is mandatory along with other relevant documents.
- b. Based on the submitted details, necessary updation in the RFP details, if required, shall be made in the MSTC platform subsequently which will be effective from Tranche VI.
- c. All the existing FSAs with the concerned EUP are liable to be amended to reflect the change in capacity/relevant details. The responsibility of intimating such change and submitting the required supporting documents to the concerned coal company will be on the bidder.

The Bidder shall provide all required supporting documents along with revised undertaking and Affidavit (in originals) and any additional documents requested by the coal company, evidencing the change, at the time of signing amended/revised FSAs.

- d. The Final Normative Coal Requirement of such bidders shall be subject to verification by CIMFR/verification agency post execution of the FSA.
- e. In case it is found at any stage that the bidder has misrepresented any facts, the bidder shall be liable for penal action in accordance with the provisions of the Scheme Document/ FSA.
- f. CIL/Coal Company/Auction service provider shall have right to cancel/withdraw such modification requested by the bidder.

Any bidder requesting for a change in capacity/relevant details on the basis of this notice shall be deemed to have unconditionally accepted the above terms.
