# NOTICE FOR THE POWER SECTOR CONSUMERS (INCL. IPPs)

Sub: Decision of 295th CFDs meeting regarding Premium to be charged for supplies to the plants not having FSA with concerned coal companies/CIL under flexi-utilization policy

This is for kind information to all concerned Power Consumers (incl. IPPs) that in continuation to the e-mail dated 01.12.2022 from Associate Finance, M&S, CIL, the Chief Manager (M&S-I/c FSA/Linkage), CIL, Kolkata vide letter No. CIL/M&S/Power/617 dated 06.12.2022 has communicated the decision of 295th CFDs meet of CIL held on 22.11.2022 at CIL, Kolkata regarding the approval for premium to be charged for supplies to the plants not having FSA with concerned coal companies/CIL under flexi-utilization policy. The decision of CFDs is reproduced below:

### Quote

"CFDs after detailed deliberation accorded approval for charging of 40% premium over and above basic RoM notified price for both type A (Plants having no FSA with the respective subsidiary of CIL) and Type B (Plants having no FSA with any of the subsidiary of CIL) power plants for supply of coal under flexi utilization policy, to bring it at par with other cases of supply to the plants not having FSA and supplies within the initial period of 3 years under Bridge Linkage. The revised pricing shall be made applicable from the date of decision of CFDs."

In view of the above, this is to notify that a premium of 40% over and above basic ROM notified price shall be applicable for the coal supplies made w.e.f. 22-11-2022 under flexi-utilization policy to the power plants (incl. IPPs) not having FSA with CCL and with any of the subsidiary of CIL.
