URGENCY MINUTES

In view of the urgency expressed by GM(M&S), the extract of the Minutes of the 2022:38th Empowered Committee of Functional Directors(ECFD) meeting held on 08-12-2022, in respect of following item is forwarded as below:

Item No.:

38.02: Proposal seeking approval for continuing the use of Kargali II siding under RCR mode till departmental utilization of siding resumes or March 23, whichever is earlier.


GM(M&S) apprised the ECFD regarding the subject proposal as detailed below:

- 1) The offer for use of Kargali-II Siding under RCR Mode and subsequent extension for two months was earlier approved by ECFD in its 28th meeting held on 07-10-2022, which is valid till 07-12-2022.
- 2) Now, the concerned Area has communicated that as on date 69 value paid arrear rakes are pending for supply from Kargali-II PF Siding under E Auction Category and till date no departmental utilization of siding can be assured and hence further extension may be agreed till departmental utilization of siding resumes or 31st March 2023, whichever is earlier.

Keeping in view of the urgency proposed by GM(B&K) and recommended by GM(M&S), the ECFD agreed for the proposed continuation for the use of Kargali-II under RCR mode till departmental utilization of siding resumes or 31st March, 2023, whichever is earlier, as brought out in the agenda note.

It is therefore, requested to kindly peruse the above and take necessary action under intimation to this office.
