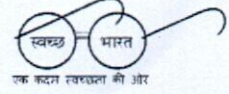



NOTICE FOR RAIL MODE CONSUMERS

Consumers planning to take coal under Rail Mode from CCL under respective schemes for January 2023 are hereby notified to file Rail Program latest by 28th December 2022 so that rail programs can be processed. Further following points may please be complied for better co-ordination:

- 1) Consumers are requested to file separate FSA (Contract) wise Rail Program and details of rail program may please be provided as per format (Attached as Annex A) at following mail id's "oprnsnmcc13@gmail.com" . In case of any ambiguity , Rail Operation Section at M&S Department of CCL may please be contacted before filing of Rail Program.
(Above issue has been notified earlier also vide notice no 2696 dt 27/12/2021 and subsequent notices)
- 2) In cases where of details of contract no. is not provided by consumers , Rail Program shall be tagged at CCL end and accordingly FSA wise invoices shall be generated.
- 3) Sale Orders and Proforma Invoice (PI) against MSQ (Monthly Scheduled Quantity) shall be generated and sent by CCL Over E Mail to Consumers. Consumers may arrange deposition of advance payment of coal value through **PAYMENT GATEWAY** in reference to the Proforma Invoice developed by CCL against supplies for the month of January 2023 as an alternative to the pre-existing syatem. Details regarding **PAYMENT GATEWAY** has been notified vide Ref No. Ref No - CCL/M&s/Notice/2022-23/198 dated 21/10/2022
