
3. **EXPERIENCE:**

I. COMPANY PROFILE

Central Mine Planning & Design Institute Limited (CMPDIL) was incorporated under the Indian Companies Act, 1956 with the objective to provide total consultancy in coal/mineral exploration, mining planning & design, coal beneficiation & utilization, allied engineering services, human resource development, environmental engineering, information & communication technology, geomatics services, laboratory and fields services as a premier consultant in India as well as at international level. CMPDIL is a schedule - 'B'/Mini Ratna (Category-I) CPSE with the administrative jurisdiction of Ministry of Coal.

Its Registered and Corporate office are at Ranchi, Jharkhand only.

The authorized and paid up capital of the Company were Rs. 150 crore and Rs.142.80 crore respectively as on 16.11.2021.

CMPDIL is a 100% subsidiary of Coal India Limited.

The company employed 3024 regular employees [Executives 811, Non-executives 2213] as on 16.11.2021.

Director (Technical) is a member of the Board of Directors of CMPDIL and reports to Chairman and Managing Director. He/She advises in matters relating to exploration, mines safety and technical activities.

VI. UNDERTAKING BY THE APPLICANT

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
