
They will be on probation for a period of 06 months as per the clause 3.6 of Certified Standing Orders of the company.

In view of the CIL guidelines on determination of seniority in case of Non-Executive cadre employees of CIL and its subsidiaries circulated vide reference no. CIL/C-5B/JBCCI-X/SC/determination of seniority/33 dated 11-02-2021, the aforementioned employees are directed to report for their duties on promoted post at the earliest and not later than 30 days of issue of this order. If the concerned employees does not join within 30 days of the issuance of office order, the same shall be stand cancelled.

The GM/HOD of the Department (Disciplinary Authority as per Certified Standing Order of the Company) to ensure that the joining to the selected post is accepted only, If there is no departmental disciplinary case pending against the above named 94 employees with intimation to this office, only after which their selection would be effected.
