#### I. COMPANY PROFILE

WCL, Miniratna Cat. 1 PSU is a subsidiary of Maharatna Public Sector Undertaking- CIL. It came into existence on 1st November, 1975. It is engaged in mining of Coal through its mines spread in its 10 Areas located in the States of Madhya Pradesh and Maharashtra. Bifurcated in January 1986, SECL was carved out from WCL with 67 Mines producing 30.71 MT. With this bifurcation, WCL was left with 60 mines producing 18.17 MT. At present there are 55 producing mines viz 21 underground and 34 Opencast Mines. It is marketing Coal with a strong customer base comprising Power, Cement, Steel, Chemicals, Fertilizers. Paper and Brick Kilns etc in South, West and Central India. WCL has been conferred Mini Ratna status on 15th March 2007. It contributes nearly 8% of National Coal Production from nearly 6% of National Geological Coal Reserves. The reserves in WCL command area are deep seated and are of scattered nature thereby translating into highest stripping ratio amongst all subsidiaries of CIL and non-amenable to Mega Mines. After peaking its production in 2009-10 at 45.74 MT the down trend in production started culminating into 39.73 MT in 2013-14. Record 20 New Mines were thereafter opened in next 2 years coupled with subsequent opening of 5 more mines in later year resulting in consecutive growth of coal production year over year thereby attaining record production of 57.71 MT in 2021-22. Several out of box initiatives were pioneered in last six years earning WCL, a coveted tag of being an innovative Coal Company. The out of box ideas were successfully implemented and was later

chosen and directed for being replicated in other Mining Company not only in Coal Mining but for the Mining Industry as whole. Some of the prominent initiatives includes Sand from Overburden, Eco Mine Tourism, Gainful Utilization of Mine discharge water, Commercial Sale of Overburden etc.

The company employed 35327 regular employees (Executives- 2025 & Non-executives- 33302) as on 01.07.2022.

Its Registered and Corporate Offices are at Nagpur, Maharashtra.

The authorized and paid up share capital of the Company was Rs. 800 crore and Rs. 297.10 crore respectively as on 31.03.2022.

WCL is a wholly owned subsidiary of Coal India Limited.
